

#SponsorMeStegbar Promotion

TERMS & CONDITIONS

- The promotor is Stegbar Pty Limited ABN 52 007 090 820, of Level 3, 78 Waterloo Rd, Macquarie Park, NSW, a subsidiary of JELD-WEN Australia Pty Limited.
- Information/Instructions on how to enter this promotion forms part of these conditions. Entry into this promotion will be deemed as acknowledgement and acceptance by you of these terms and conditions governing this promotion. This promotion is not valid in conjunction with any other offer.
- This promotion commences on the 16th of November 2020 at 9am (AEST) and concludes on the 16th of December 2020 at 5pm (AEST) (**Promotion Period**).

PRIZE
